Under the Public Services Reform (Scotland) Act 2010, we have, along with other public bodies in Scotland, a duty to publish annual public statements relating to our expenditure in the following areas:

Sustainable growth

HIE's purpose, 'to generate sustainable economic growth in every part of the Highlands and Islands' is derived directly from Scotland's Economic Strategy. Through the pursuit of four priorities we work toward realising our vision of a Highlands and Islands that is a highly successful and competitive region in which increasing numbers of people choose to live, work, study and invest.

This includes the examples that illustrate the breadth of interventions HIE makes to improve prosperity and quality of life for current and future residents right across the region.

Efficiency, effectiveness and economy

HIE is constantly engaged in identifying opportunities to increase efficiency, lower costs and improve service quality. In ensuring Block B (HIE's management and administration budget) remains on target, costs must be contained and inflation absorbed. In the current year (2016/17) net savings amounting to £0.25m were delivered through detailed focus on accommodation and utility costs incurred by HIE.

In May 2016, Inverness and Dingwall-based staff moved to new premises at Inverness Campus,. This office has a smaller footprint delivered by reducing the desk-to-person ratio. This smaller footprint has had a consequential impact on running costs.

Improvements in efficiency and effectiveness over the last 7 years have enabled HIE to reduce management and administration costs by £3 million (17%).
